The board of directors ("**Board**") of Ramba Energy Limited (the "**Company**", and together with its subsidiaries, the "**Group**") refers to the Announcements and is pleased to announce that approval from *Satuan Kerja Khusus Pelaksana Kegiatan Usaha Hulu Minyak dan Gas Bumi* (SKK Migas) to the Farm-Out of a 15% participating interest in the Lemang PSC to Mandala Energy Lemang Pte. Ltd ("**Mandala**") has been obtained on 5 June 2018 and consequently all conditions to the Farm-Out have been satisfied.

The participating interests of Hexindo, Mandala and Eastwin Global Investment Limited in Lemang PSC following the completion are 16%, 50%, and 34% respectively.
